

About the Observance of the 50th Anniversary of the May 1970 Augusta Riot

1970 Augusta Riot Observance Committee

May 2020 will mark the 50th anniversary of Augusta's violent civil rights uprising. On May 11-12, 1970, a protest turned violent and the lives of six men were lost in downtown Augusta. On the afternoon of May 11, 1970, Black Augustans gathered at City Hall to protest a suspected act of police brutality that crystalized the severe racism of Augusta.

Two days prior, Black leaders faced the evidence of torture on the body of a Black 16-year-old boy, Charles Oatman, who had died while in custody at the City Jail. Out of frustration, some protesters set fire to locally owned businesses in the area now known as the Laney Walker and Bethlehem neighborhoods. The uprising grew in scale and number, but police mobilized, firing rounds throughout the night. By dawn, police had shot in the back and killed six black men and boys. Many more people were wounded.

A diverse group of community leaders, historians and local organizations are planning a commemoration to mark the 50-year anniversary of these events. Currently the events include a Candlelight Vigil at May Park, State Marker Unveiling at the Municipal Building, Keynote Speaker and Reconciliation Service, previewing of "The Steering Committee" film accompanied with a history panel discussion, a panel discussion on the 1970 Riot with eye witnesses, a Student art show and podcast listening party, and several visual art exhibitions and public art events.
